

CONSENT TO THE COLLECTION, RETENTION, USE AND DISCLOSURE OF PERSONAL INFORMATION

2. Gender;

4. Contact information;
5. Current and past address(es);
6. Employment information;
7. Financial information;
8. Marital status;
9. Residency/citizenship status.

Additional personal information may be collected from time to time. Consent for the use of this personal information may be inferred where its uses are obvious and it has been voluntarily provided. When not obvious, the purposes for collection will be provided prior to or at the time of collection, either orally or in writing.

Any person wishing to review personal information held by Main St. Mortgage and/or any related entities may do so by requesting same from a representative of Main St. Mortgage and/or the related entity. Further, any person may withdraw consent to the collection, retention, use, and/or disclosure of any or all personal information by Main St. Mortgage and/or any related entity (although this may restrict or interfere with any services being provided by Main St. Mortgage and/or other entities), subject to any legal obligations governing the continued collection, retention, use and/or retention of such personal information, by contacting a representative of Main St. Mortgage and/or the related entity.
